

Self-issued Life and Funeral Expenses Insurance Coverages

BASIC COVERAGE

Death due to natural or accidental causes:

- Payment to Beneficiaries of the agreed face amount Applies for plan A and plan B
- Death from natural or accidental causes

FUNERAL EXPENSES COVERAGE

Optional Coverage

Additional compensation will be granted to cover funeral expenses up to a limit of 20% of the Basic face amount

- Applies to plan B
